WEBSITE PRIVACY POLICY AND LEGAL NOTICE

Ovens-Ballincollig Medical Group are committed to best practice compliance with the EU General Data Protection Regulation.

What information do we collect about you?

When you attend or register with us a patient, we collect the personal details specified in the patient registration form. With your prior knowledge and consent, we may take up copies of your medical records from a previous GP etc. Your GP is also likely to receive updates from other health professionals, hospitals etc involved in your treatment and care.

Why do we collect this information?

We collect this information to provide appropriate treatment and services to you to ensure your continuity of care and patient safety.

On what basis do we process this information?

Your personal information is mostly collected directly from you and processed by us with your knowledge and express consent. You may withdraw your consent to the processing of your personal information at any time.

Who will we share your information with?

We may share your information with other healthcare professionals and third party service providers, e.g. laboratories when it is necessary and appropriate for your treatment and care.

How long do we keep hold of your information?

We keep records from 2003 since we became computerised.
